Newsletter Gets A New Name

The ABBPG Board voted, in its January meeting, to adopt "The Peninsula Pelican" as the name of the official newsletter. As you know, "The Newsletter" was previously unnamed.

Why "pelican"? Well, if there was a mascot candidate, then pelican surely would be on the list. Seal Beach has an obvious choice of mascots, and the Peninsula has a few choices. Other suggestions included the sandpiper and the great blue heron. Sandpipers are evidently very social, but they had a small lobby. The great blue heron is truly majestic, and has made a recovery from near extinction in the past 20 years. Some residents have pet names for the herons on the bay, such as "Hank Heron". Or should it be "Henrietta"?

Pelicans can be seen several months a year just off the beaches. Who has not stopped to stare when one dives from 40 feet straight down for a bite to eat? Who has not marveled at the huge wingspan or the tight gliding formations? If the sun were at different angles a beach walker might sense an air attack as the wings block out the sun.

2005 Resident Survey Results Tabulated

The results of the 2005 Resident Survey are now tabulated. We had a tremendous response of around 250 people taking the time to respond. Questions covered important issues that included zoning, traffic, safety, neighborhood cleanliness, and the role of ABPPG. The results have been tabulated and the ABBPG Board has met to discuss the results. The board felt that the survey showed that intense study is needed to formulate policy in specific areas.

Some of the results are as follows.

SAFETY. A strong majority (118 to 47) favored an increased law enforcement presence on the Peninsula. One hundred five residents were aware of recent crime on 72nd Place, while 88 were not aware of this. One hundred thirty seven residents support additional lighting on Bayshore, the Boardwalk or 72nd Place. Eighty two do not.

TRAFFIC Several traffic concerns were addressed. The question "Does there remain a speeding problem?" brought 125 "YES" responses versus 65 "NO". When asked if residents support more stop signs twice as many residents said "no" as "yes". One hundred eight residents responded "no" to additional mechanisms such as speed bumps, out-voting the 74 who thought it was a good idea.

ZONING. Many zoning questions were addressed as well. A majority favored the ABBPG continuing to actively oppose height and parking variances (150 to 25). Also a majority favored actively opposing variances in addition to parking and height 115 to 47. However when asked specifically what such variances should be addresses, 19 said parking or height. Sixty two gave no response, while only 4 expressed desire to oppose all variances. this prompted the board to specifically analyze the survey in committee meetings.

PENINSULA CLEANLINESS. Several questions were addressed. Residents felt that generally the street sweeping program is effective. However there was a tie (70 to 70) when asked if the Bayshore Walk sweeping is effective. Responders pointed to cleanliness problems of the Bay Beach, and more strongly at the Ocean Beach and

72nd Place. Parking Lots and Jetty. Responders were veenly divided as to whether dogs on the beach is a problem.

ROLE OF ABBPG ON LOCAL AND CITY ISSUES. When asked if the ABBPG should take positions before the City on issues (such as MTV) directly affecting the Peninsula, responders overwhelmingly said "yes". But the responders voted a strong "NO" as to whether issues not directly affecting the Peninsula should be addressed.

Community Emergency Response Team (CERT)



Want to train to become a First Responder in case of emergency? Want to be trained in Search and Rescue? First Aid without a kit? Fire suppression? What steps are necessary for our neighborhood in case of a disaster if all city resources are absorbed elsewhere? Do you want to know more about what happens in a major disaster such as a huge earthquake? All of these topics are part of the training we receive as part of CERT.

CERT has been active on the Peninsula for three years now. Activities include courses from the Fire Department, members lectures, and simulation drills complete with a command center, fire boats and helicopters.

Our Peninsula CERT meeting in February covered several topics:

1. How to mobilize our Peninsula CERT organization during an emergency.

We were requested to support City CERT activities relative to flood control during the heavy rains in January and February. This led to a need to have a pre-planned method to contact our members.

We are exploring several approaches including 1) Verizon group mail; 2) establishing a phone tree; 3) reverse 911; 4) FRS radio

2. Setting up a field trip to the LBFD Training Center to observe a Search and Rescue Session
3. First Aid without a Kit – This is an on-going topic in our monthly meetings presented by Dr. Ed Shackeroff in which he demonstrates how we can improvise in first aid situations with available materials and equipment. All CERT members are encouraged to carry First Aid kits but we could face many problems where we will need to go beyond kit contents.
4. Next Drill – We plan to have our next Peninsula CERT practice drill in June and expect it to include demonstrations of first aid, emergency radio communications, and coordination with LBFD CERT and equipment. We hope to have more to report on this at the April 20th General meeting

Peninsula Improvement Committee

Hello Peninsula!

This is the first report in the Peninsula Pelican from the combined PIC Chairs Linda McCullough and Rick Brizendine.

OUR MEDIAN is shaping up nicely! It will not be finished until the goal of \$200,000 is reached. If you have not yet donated NOW is the time. If you already have given, we would appreciate your continued donations. As you know, the plants maintenance is ongoing so the greater the collection the prettier the Median will remain.

Remember, come April 15 your donation is tax deductible! UNDERGROUND UTILITIES are being considered.

Naples is looking into forming an assessment district to achieve this. For any community this is an undisputed benefit as well as a long term project. We will keep you updated on Naples' progress and would appreciate hearing from you about your opinion on the subject. Without community support this will not happen.

TRASH RECEPTACLES are a big issue in any public park. The Peninsula is not unlike any other area the public is invited to. Even if our City were not experiencing a budget crunch it makes sense to reserve the street end trash cans for the visitors and our occasional needs.

While our City is trying to save money-removing the trash cans during off peak times being one way-it makes even more sense for neighbors to remind neighbors that the PUBLIC trash receptacles are for the PUBLIC and neighbors could be ticketed for using them for their household trash. Thank you for not making this a BIG issue.

THE EAST END of the Peninsula, 72nd Place parking lot and park, is a public place and therefore difficult to control from a neighborhood platform. Just think Coastal Commission. What we can do from here is to convince the City to add some decorative mid size rocks and an appropriately placed large trash receptacle to deter drivers from avoiding the closed parking lot, add more light to the parking lot and signs declaring the lot closed from 1 hour after sunset to sunrise so ticketing can occur-the City has agreed to this. Let's be hopeful this is beneficial and remember-all justified "calls for service" to the Long Beach Police Department will result in additional patrols. THE BERMS come and go when the tide is high and there is a low pressure area above us and there is a wind or storm swell. Enough variables for you? What's more interesting are the old artificial wooden groins visible in the last low, low tide. These will be studied and removed and the new sand filled plastic bag artificial groins will be studied and repaired. Where this all ends no one knows.

Security Committee Report

The Long Beach Police Department East Division holds a monthly meeting with representatives of neighborhood groups located within the East Division. The following is a summary of crime in the East Division for February, 2005, provided by Commander Quach during the meeting of 9 March 2005.

1. Violent crime is down compared to previous month
2. 116 auto burglaries – 15 in Peninsula/Belmont Shore/Naples area (Beat 10)
 - a. 65% from unlocked cars
 - b. majority of stolen items were cell phones
 - c. Lesson – don't leave car unlocked and/or cell phones where visible
3. 23 commercial burglaries – mostly from men's lockers in fitness facilities
4. 18 garage burglaries
5. 38 residential burglaries – 2 in Beat 10
6. 85 auto thefts – 2 in beat 10
7. East Division is providing additional in-school and exterior uniformed officers at Wilson and Milliken High Schools
8. Parts of two segments of Joan of Arcadia were filmed at 4th and Cherry
