## *President's Message--May 2010*

Our Spring Community Meeting (April 22) was a big success. We heard from our new **Long Beach Chief of Police, Jim McDonnell** as well as recently re-elected **Councilman Gary DeLong**. The presentation evoking the most questions was done by **Colonel Thomas Magness** from the Army Corps of Engineers. He provided an update on the consideration of the recently completed breakwater study and his recommendation to proceed with the Army Corps Reconnaissance Study. This would be an eight (8) million dollar study funded partly by the Federal Government and partly by Long Beach. It is expected to take nearly eight years to complete.

There continues to be a push by the SurfRider Foundation and others to remove or lower the breakwater to increase waves for surfing. Some members of the Long Beach City Council are listening to the SurfRiders. Councilman Robert Garcia recently sponsored a letter writing campaign to support the breakwater study. City Councilmember Patrick O'Donnell has been hosting events in his campaign to make the month of May the Breakwater Awareness Month (BAM).

The Peninsula Beach Preservation Group, as a result of our surveys of residents, continues to take a position that the safety of property comes ahead of improving wave quality for

recreational use. There are others who have serious concerns about alterations to the breakwater as well. We recently received a copy of a letter from the Pacific Merchant Shipping Association and the Jacobsen Pilot Services to the Army Corps of Engineers. The letter expresses their concern that "major modifications to the Breakwater will create risks to navigation and commerce threatening the economic viability for the Port of Long Beach and the Southern California region. We will continue to monitor this issue and report updates as available".

As we look forward to a GREAT summer on the Peninsula, please see the announcement of our Summer Concert Series elsewhere in this newsletter. It looks to be a fun line-up of bands. Please join in on the fun.

Our 2010 membership drive is underway. At \$25 per year, membership is an incredible value. We work hard, but we need your support to do the many things that help make this neighborhood extra special. **3rd District Council Office Update**

One of the most important projects for the 3rd District is the redevelopment of the Seaport Marina property. The proposed Second+PCH project, a mixed-use development with 325 residential units, retail, commercial development, and a 100-room hotel, is currently accepting comments on the Environmental Impact Report (EIR). Comments must be submitted in writing by June 7, 2010.

In addition to the proposed project the EIR also examines the following alternative projects:

**No Project/No Development Alternative:** The No Project/No Development Alternative assumes that the Second+PCH project will not be developed and development of the project site with new uses and structures will not occur.

**No Project/Existing Zoning Alternative:** The No Project/Existing Zoning Alternative assumes that the Second+PCH project will not be developed, but the project site would be redeveloped with commercial uses to the extent allowable under existing zoning.

**Hotel Only Alternative:** The Hotel Only Alternative assumes that the Second+PCH project will not be developed, but the project site would be redeveloped with a new full service hotel and supporting uses (e.g., restaurant, retail, car rental, etc.).

**Reduced Intensity Alternative:** The Reduced Intensity Alternative reduces key components of the proposed project in order to reduce and avoid project impacts while still meeting, albeit to a lesser extent, most of the project’s basic objectives. Thus, the Reduced Intensity Alternative would result in an overall 50 % reduction in development intensity relative to the proposed project.

Unfortunately, I am concerned that the traffic study performed by City staff and an outside traffic consultant appears to be flawed, and needs to be corrected. Additionally, the changes that were made to create the Reduced Intensity Alternative don’t appear to meet the needs of the community.

The redevelopment of the Seaport Marina Hotel is an important project for our community. At the end of the public process, I do expect to support some type of development at this location and I look forward to hearing your thoughts as to what type of development should be allowed.

**BEACH AND SIDEWALK MAINTENANCE:**

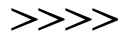

**Zoning Report**

The problem of people renting their houses by the day is being actively addressed by the city. It can be a real problem to live next door [or close to] a daily rental. Many are operated like unmanaged hotels. They cause parking, noise, and other problems. Short term rentals are not allowed by Long Beach Municipal Code under Section 21. The Zoning Ordinance Section 21.31.110. This section states allowed Residential Permitted Uses. Short term rentals are not a permitted use. If you are having a problem with short term rentals please contact Peter Ronca, Principal Building Inspector, City of Long Beach, at 562-570-6515. He is in charge of enforcement of this area of the building code. He has been very responsive to the communities concerns. If you would like me to monitor the city's progress let me know. Only the city not the PBPG has enforcement powers.

We have been getting questions - "does the ordinance prohibit daily or daily and weekly or both plus monthly rentals, or what?" Daily and weekly rentals are not allowed by code. Month to Month rentals are allowed but if the property is rented to a different person each month it would not be allowed by code.
